Local Government Act Implementation Update

The new Local Government Act 2020 is the most ambitious reform to the local government sector in over 30 years. The Act will improve local government democracy, accountability, and service delivery for all Victorians.

The following Bulletin was issued on 3 May to the sector and is shared here for information.

LOCAL GOVERNMENT PERFORMANCE REPORTING STEERING COMMITTEE - NOMINATIONS

The Local Government Performance Reporting Framework (LGPRF) and Know Your Council (KYC) website were launched in 2015 and remain the core performance reporting platform for councils across Victoria.

The framework is subject to governance oversight by a steering committee of representatives from the local government sector, peak bodies and Local Government Victoria (LGV) with a view to the ongoing review and improvement of the LGPRF.

The Steering Committee comprises 19 members, including sector peak bodies and thirteen council CEOs. Committee meetings are held online via Microsoft Teams twice annually.

Local Government Victoria is seeking nominations from the Rural, Western and Metro/Northern council groups, for three Steering Committee vacancies. The committee is currently overseeing work on the introduction of targets, revisions to indicators and process resulting from the 2021 technical working group reviews and system enhancements to streamline reporting.

Local Government Finance Project

As indicated in Bradley's opening message, FinPro, in partnership with the MAV, has commenced a project on the financial state of the sector. Mark Davies, who will be well known to you all, is assisting us. The project will undertake a review of the impact of rate capping and other key revenue factors on the viability of the sector since its introduction in 2016-17. It will also assess the financial outlook for the sector over the next five to ten years.

The project will be drawing on existing data sets and financial plans prepared by councils.

The FinPro representatives on this project are Binda Gokhale and Nathan Morsillo.

- Fraud Control Over Local Government Grants



Fraud Control Over Local Government Grants

Are fraud and corruption controls over local government grants are well designed and operating as intended?

Why this audit is important

In 2020–21, Victorian councils distributed more than \$45 million in grants to individuals, businesses and community groups.

It is important that councils have effective controls for their grant programs to prevent fraud and give their communities confidence that public money is spent as intended.

What we recommended

We made 9 recommendations to all Victorian councils about strengthening their fraud controls and improving their guidance and training for grant-related fraud.

We also made one recommendation to Loddon Shire Council about reviewing its community planning grant process.

What we concluded

Councils' fraud controls for their grant programs are not always well-designed and operating as intended. In some cases, they are missing.

Councils are not consistently identifying conflicts of interest, assessing applications against criteria, documenting their decisions, checking how funds are used or evaluating their grant programs' outcomes.

This unnecessarily increases the risk of fraud and makes it harder for the audited councils to show that their grant programs are transparent, equitable and benefit the community.
